## **2 HAZARDS IDENTIFICATION**

Extremely flammable.

CLASSIFICATION F+:R12.

PHYSICAL AND CHEMICAL HAZARDS

Aerosol containers can explode when heated, due to excessive pressure build-up. When sprayed on a naked flame or any incandescent material the aerosol vapours can be ignited.

# **4 FIRST-AID MEASURES**

## INHALATION

In case of inhalation of spray mist: Move person into fresh air and keep at rest. Get medical attention if any discomfort continues.
